A reference is invited to the Ordinances, Regulations and syllabi relating to the Bachelor of Pharmacy (B.Pharm.) degree course vide Pamphlet No. 187 and to this office Circular No. UG/175 of 2007, dated 3rd May, 2007 and the Director, Mumbai University of Chemical Technology and the Principals of the affiliated Collages in Pharmacy are hereby informed that the recommendation made by the Ad-hoc Board of Studies in Pharmacy at its meeting held on 7th July, 2010 has been accepted by the Academic Council at its meeting held on 27th July, 2010 vide item No. 4.16 and subsequently approved by the Management Council at its meeting held on 5th August, 2010 vide item No. 4 and that, in accordance therewith, in exercise of the powers conferred upon it under sub Section (i) of Section 55(1) of the Maharashtra Universities Act, 1994, it has amended Regulations 4381, (Old syllabus 2003-2004) and R 5689 (Revised syllabus 2007-2008) relating to the number of attempts in various subjects have been amended to read as under and that the same have been brought into force with effect from the academic year-2010-2011.

Amended R.4381 and amended R. 5689: Number of attempts:

“A candidate is allowed a maximum of eight attempts inclusive of first attempt to pass respective Semester examination in every subject, failing which the candidate has to discontinue the course.”

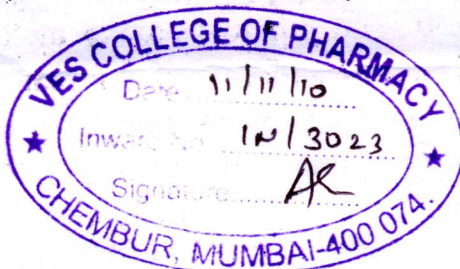


